

Special Olympics Ireland Identity Validation Form ROI Residents

Special Olympics Ireland requires all applicants for vetting to have their identity validated prior to submitting their vetting application online to An Garda Síochána National Vetting Bureau. This is a **mandatory** part of the Special Olympics Ireland volunteer registration process and complies with the National Vetting Bureau (Children and Vulnerable Persons) Acts 2012 to 2016.

Once completed and witnessed (either by a Garda <u>or</u> an alternative witness listed on page 3) please save a photo/scan of the form. Please also save photographs/scans of your identity documents (totalling 100 points or more). (see pages 4 and 5 for list of documents). Please access our membership system and upload your form and copies of your identity documents during your membership journey. You received an email from us which contained a link to the system.

If the applicant is <u>16 or 17</u> years of age the Parent/Guardian Consent Form on page 7 must be completed and returned with the Identity Validation Form.

Please note **original identity** documents must be examined by a witness. Copies of same must be uploaded to your volunteer profile on our membership system. Special Olympics Ireland will retain this form and copies of the documents for the period the applicant is a volunteer with the organisation. In the event the application is not successful these copies and ID validation will be destroyed.

Each item on the list carries a score. **The applicant must upload these documents as part of the online application process** totalling a minimum <u>score of 100.</u> The table must be ticked to confirm what documents were presented by the applicant. **AT LEAST ONE DOCUMENT MUST SHOW YOUR CURRENT ADDRESS**. <u>It is mandatory for all applicants over 18 to provide at least one form of photographic ID</u>. Please ensure you read through the list carefully.

Please note we cannot accept a Public Services Card as proof of identity.

- Special Olympics Ireland will retain this form and copies of the documents for the period the applicant is a volunteer with the organisation. In the event the application is not successful these copies and ID validation will be destroyed.
